NERT Training

The San Francisco Fire Department will be holding Eureka Valley "Neighborhood Emergency Response Team" (NERT) training on two consecutive Saturdays, March 15 and March 22, 8:30 a.m. to 5:30 p.m. at Davies Medical Center. This training is normally given in a series

of six sessions. The goal of the program is to help the residents of Eureka Valley be self-sufficient in earthquake and other major disaster situations developing multifunctional teams, crosstrained in basic skills. emergency Through this program, individuals will learn



hands-on disaster skills that will help them as members of an emergency response team and/or as a leader directing untrained volunteers during an emergency, allowing them to act independently or as an adjunct to City emergency services. There is no cost for the training. Attendees must commit to both full-day sessions.

Although the training will take place in March, the opportunity to sign up for the training is now. There is a limit to the number of persons who can be trained - so the sooner interested persons sign up, the better their chances of participating in the program.

Castro Community on Patrol

In late 2006, after several violent attacks in the Castro, we as a community decided that we needed to protect ourselves. Although the police do a great job, they have limited resources, and they can't be everywhere all the time. As a community and as a neighborhood, we are ultimately responsible for improving the safety of this great place where we live, work, and play.

We therefore founded Castro Community on Patrol, a grassroots neighborhood organization dedicated to safety awareness in the Castro and Duboce Triangle. The goal was to have walking patrols every Friday and Saturday nights to keep an eye out on the neighborhood, to create a visible presence, and to educate people about the need to promote a safe neighborhood. We decided that we did not want our patrol volunteers to become physical with anyone, but rather to be eyes and ears and to report problems.

We have now been patrolling for over 14 months, and the organization has been a success. We have had walking patrols every Friday and Saturday night with only a few exceptions during inclement weather and the holidays. People in the community know and recognize us, and people often thank our volunteers as they patrol.

Our patrols take their jobs seriously. They have helped prevent or report crimes in progress, for example stopping a hate crime that was about to occur, seeing an armed robbery in progress and calling the police immediately, and preventing several assaults. Our patrols also keep an eye out for streets that are too dark, whether from overgrown trees or burnt out streetlights, since dark streets can reduce safety.

Castro Community on Patrol is certainly not the total answer to the safety challenges confronting the Castro. But, we are part of the solution. After 14 months, we are going strong, and we hope to be a long-term presence in the neighborhood.

Upper Market Workshop Update

I spoke to Sarah Dennis at the planning department the other day to find out the status of the Upper Market She said the consultants, Moore Workshop Series. lacofano Goltsman (MIG), with Seifel Consulting, are currently at work on the document that will be the product of the community meetings. She said the Planning Department expects to receive the document from them by the end of February or early March. Then, depending on the state of the document [readiness for presentation to the public] they will be able to schedule the next workshop for the community to review the document. At that point, depending on the community input, the document can be finalized and presented to the Planning Commission. If there is significant community input that the document isn't ready to move forward, there will be a rework period. indicated that involved community groups [such as EVPA] can request additional focus work on the document and the Planning Department will accommodate them.

One thing that has to be remembered in this process is that the majority of the area [up to Noe Street] and the majority of the development opportunity sites are under the domain of the Market/Octavia Plan which has not been finalized as of yet.

The collated listing developed from our concerns expressed at the last meeting were:


- 1. Housing
 - a.) Preserving Victorian homes
 - b.) Diversity of housing (apartments, condos, flats, single family homes)
 - c.) New building to support neighborhood
- 2. Self-sustaining neighborhood: stores, transit, restaurants, groceries
- 3. Businesses
 - a.) Uniqueness of business
 - b.) Chain stores?
- 4. Preserving our residential/commercial balance
- 5. Preserving views and limiting heights of new buildings
- 6. Preserving population diversity (gay families, straight families, single people, different ethnic groups
- 7. Remembering the neighborhood's history, character and identity
 - a.) LGBT character and history
- 8. Preserving nightlife
- 9. Making the neighborhood walkable
- 10. Protecting front/rear yard open space
- 11. Ensuring adequate public transit
- 12. Maintaining and creating public space (plazas, parks, wide sidewalks, etc.)
- 13. Disaster preparedness: neighborhood needs to take care of itself
- 14. More exposed earth to facilitate water absorption into the ground
 - a.) Larger cut-outs around street trees to facilitate this goal
- 15. Public safety and safety of all residents
- 16. Utility undergrounding
- 17. Preserving (maintaining) hillside staircases

This is the just the beginning of the list. With the unveiling of a new EVPA website, we will be providing those who were unable to attend the January meeting opportunities to add their concerns.

General Membership Meeting Minutes January 2008

- 1. The president called the meeting to order at 7:30 p.m.
- 2. On motion and second, the minutes from the December 2007 meeting were approved.
- 3. The president presented the treasurer's report and reported that the EVPA account contains approximately \$9,000 and that the foundation account contains approximately \$1,000.
- The president presented the Planning Committee report, including an update on website improvements relating to planning issues and an update on planning issues in the neighborhood.
- Dennis Richards, president of DTNA, provided an updated on the work of the Upper Market Alliance, particularly UMA's meeting with Washington Mutual Management relating to the proposed site at Market and Sanchez. UMA voted to support the project.
- 6. The Frameline proposal to use the parking lot behind the Castro Theater during the LGBT Film Festival was discussed. No action was taken on the proposal, given that prior notice on the item had not been provided to the membership.
- 7. The membership discussed what "neighborhood character" meant and provided a number of different elements of that concept.
- 8. A report was provided on the neo-nazi graffiti at Pink Triangle Park, including the clean-up of the graffiti and maintenance issues relating to it. The membership expressed its appreciation to City officials and employees for their prompt attention to this crime.
- Alan Beach provided an update on efforts to plan for Halloween 2008. Members expressed their concerns about the slow progress of planning.
- Gustavo Serina provided an update on the Community Benefit District's activities relating to streetscapes in the Castro and pedestrian safety at Noe and Market Streets.
- 11. The president then adjourned the meeting.




